## HEALTH DEPARTMENT

Heath Butz, administrator, came to the council to discuss the new local public health funding from the state. He has learned most counties are opting in to the new program which makes it more likely the county will receive the minimum amount of \$222,698.25 instead of the maximum amount of \$296,931 for 2024. The health maintenance and trust funds will no longer be funded, if the county opts into the new funding. The department has been looking at new positions with the funding including a school health liaison who will be a link between the health department and the school. The job would include any schools in the county including private schools. All screenings and initiatives on the new health program would be handled by the liaison. 92 counties on obesity, community including Butz is hoping the new program would increase the overall health of the county. Jay County is currently ranked 90th out of counties on obesity, 75th for smoking, and 77th in infant mortality. The position would work with other health entities in the are also considering adding a health educator position. Mr. Butz indicated a form will need to be approved and signed It is a two-year commitment and will need to be redone again after the two years. July 1, 2023 to 5 commissioner appoints and 1 fiscal body appointment. Another change will be the largest city in the county will give 3 recommendations to the commissioners for appointments. Cindy Bracy questioned what the next steps were to opt into the program. Mr. Butz indicated a form will need to be approved and signed by the commissioners by September 1, 2023 The department will be allowed to do utilize pass thru funding. Their idea is to help fund those who are already doing the work

in the budget to hire without receiving approval from the personnel committee. It would not impact a new position which would still be required to seek approval from the personnel committee and council prior to hiring. Matt Minnich questioned if the exit interviews were still be completed by the departments. Jeanne Houchins indicated most had been completing the form AMENDMENT ORDINANCE 2022-11
The personnel committee has made the recommendation to amend Ordinance 2022-11 to allow those positions already funded with the exception of those who are quitting without two weeks' notice.

scheduling citing only one deputy was on duty at night but had heard from another source on June 21, 2023 during the daytime 7 county officers showed up within 10 minutes of the incident. had been called to the scene. There were two impaired individuals hanging around their property in which he called 911. One individual was belligerent and tried to get into their home and one individual ended up passed in the yard. They were told by dispatchers the county officer on duty was busy on a call and a Portland Police Officer

hold transport to Ball, they would have answered the call. The practice of other departments picking up emergency calls is not that uncommon of a practice. She also referenced the amount of time it would take to get to the call geographically as they lived in the far southeast section of the county. Mr. Emery again questioned why seven officers were able to come during the day and why they did not schedule more during the night shift. Ms. Houchins stated the administrative officers on duty during the day were not necessarily road officers. However, they might go out depending on the severity of the call.
